Caesars Sportsbook – U.S. "Bet & Get" Promotion Parking Validation at Caesars Sportsbook at Rocket Mortgage FieldHouse Terms and Conditions

PROMOTION OVERVIEW: These terms and conditions govern the Parking Validation at Caesars Sportsbook at Rocket Mortgage FieldHouse Promotion (the "<u>Promotion</u>") where registered Caesars Sportsbook U.S. players can receive validated parking for the Arena Lot in downtown Cleveland, OH when they make a qualifying wager of \$20 of more at Caesars Sportsbook at Rocket Mortgage FieldHouse. This promotion is offered by American Wagering, Inc. ("Caesars").

The promotion's details will be disclosed in the offer materials for the promotion, which may include, the Caesars Sportsbook promotions page (sportsbook.caesars.com/us/oh/bet/promos), a registered player's personalized promotions webpage, and/or emails or other communications sent directly to a player (collectively, the "Promotion Offer Materials").

The promotion starts and ends on the dates/times set forth in the Promotion Offer Materials (the "Promotion Period"). For this specific offer, the promotion is valid when Caesars Sportsbook at Rocket Mortgage FieldHouse is open from 11:00 AM - 11:00 PM local time every day of the week, and when Event Day Parking is not in effect at the Arena Lot. This promotion will end when Caesars removes the promotion from its promotion websites and/or onsite signage.

ELIGIBILITY:

- 1. To be eligible for a promotion, you must:
 - a. Be 21 years of age or older;
 - b. Be physically present at Caesars Sportsbook at Rocket Mortgage FieldHouse in Cleveland, OH while wagering; and
 - c. Remain in good standing during the entire Promotion Period.
- 2. Other eligibility requirements may be communicated in the Promotion Offer Materials.
- 3. The following individuals are <u>not</u> eligible for any promotions:

- 2. Participants will then need to go to Caesars Sportsbook at Rocket Mortgage FieldHouse during the Promotional Period to place a Qualifying Wager of \$20 or more at the ticket window or kiosk.
- 3. Once the Qualifying Wager is placed, participants will need to show the bet slip to a staff member at Caesars Sportsbook.
- 4. The Qualifying Wager must be placed on the same day that the parking is validated.
- 5. The Caesars Sportsbook staff member will validate the parking for this guest and provide the guest with a barcode for them to scan when leaving the Arena Lot after their visit to Caesars Sportsbook at Rocket Mortgage FieldHouse.

PARKING VALIDATION TERMS AND CONDITIONS:

- 6. Parking can only be validated if the Qualifying Bet is placed during the Promotion Period. The Promotion Period is whenever Caesars Sportsbook is open (11:00 AM 11:00 PM) and when Event Day Parking is not in effect at the Arena Lot.
 - a. When Event Day Parking is in effect, it will be marked by onsite signage at the Arena Lot. All onsite signage at the Arena Lot that shares this promotion will also be removed when Event Day Parking is in effect.
- 7. Qualified Participants will earn a maximum of (1) parking validation per day.
- 8. The parking validation barcode that a participant receives can only be redeemed for one (1) exit from the Arena Lot.
- 9. Qualified Participants must leave the Arena Lot by 11:59 PM local time on the day that their parking was validated.

ADDITIONAL TERMS AND CONDITIONS

- 10. All references to sums of money in the Promotion Offer Materials are in United States currency.
- 11. This promotion may not be combined with any other offers or promotions. For purposes of these terms and conditions, the "<u>Promotion Entities</u>" means Caesars, Caesars' parent and each of Caesars' affiliated and subsidiary companies, along with each of their respective officers, directors, shareholders, members, employees, and agents.
